More than 300 graduates looking to land jobs in the Accountancy Sector showed up, all ready to impress the 17 employers on hand with their resumes in hand.

This time round, Be.Recognised@Mar2016 was also open to polytechnic graduates in accountancy looking to get a leg-up in the sector.

To better cater to the accountancy diploma holders, the SkillsFuture Earn and Learn Programme for Accountancy was introduced through the [SAC-NP Advanced Diploma in Accountancy](#), which will open up a new pathway to attain the [Chartered Accountant of Singapore](#) professional designation via the [Singapore QP](#).

Stephanie Chua, Director of 3E Accounting said: "We think such career fairs are good for firms like us as they help to create awareness about our company among candidates, who might not be familiar with the smaller niche accounting firms."

Vincent Tang, Senior Manager, Audit and Assurance, UHY Lee Seng Chan & Co said: "Career fairs like these provide good exposure for both companies and candidates. We get good spontaneous interaction with the candidates and they get to deposit their resume with us and to find out more about our firm."

Former president of the SIM Accountancy Club, Giovani Anggasta, 23, says that she gets to learn about employers' expectations and appreciates the instant feedback that she gets from them.

"We get to speak directly with the hiring managers, and this is helpful because we can get answers that we will not be able to find normally on their company websites," she said.
