

SBF ManpowerConnect Scheme

SBF ManpowerConnect is a temporary scheme set up to help companies in the Manufacturing and Services sectors better manage their manpower needs in view of the COVID-19 situation.

As entry approvals for new work pass holders from overseas remain limited to reduce the risk of importation of COVID-19 to Singapore, the temporary scheme has been extended to 31 August 2021 to help more companies hire workers who are already in Singapore. The temporary arrangement allowing transfers across sectors was discontinued from 1 March 2021, in view of the low demand for such transfers.
